Landscape Maintenance Specifications for Green Ridge HOA

TREE AND SHRUB CARE

- All shrubbery shall be properly pruned, trimmed, and shaped as needed and/or necessary.
- 2. Pruning and trimming of trees will be completed as necessary.
- 3. Major pruning, trimming, thinning, and cabling of trees over 12 feet in height will be an extra charge.
- 4. Any major hedging down and/or back of shrubbery can be determined an extra charge.
- 6. Trees and shrubs shall be fertilized as needed.
- 7. Any plant nutrition deficiencies shall be corrected.
- 8. Removal of any plant material damaged by other parties other than the contractor and/or mother nature may have an extra charge.
- 9. All plant insect disease control will be completed as necessary.
- 10. Twice yearly application of pre-emergence weed control for two (2) entrances and three (3) roundabouts.

CLEAN-UP OF COMMON AREAS

- All clippings, trimmings, and other debris generated during the working day will be removed by the end of the day.
- 2. Any trash accumulated in planted areas will be cleaned as needed on a monthly basis.
- 3. All decomposed granite areas shall be raked once per month.

IRRIGATION REPAIRS AND MAINTENANCE

- 1. All irrigation valves, timing devices, and heads will be checked monthly to insure proper system operation.
- Gardens and More, LLC shall maintain control of irrigation timers. Irrigation
 controller scheduling and adjustments will be completed according to the seasonal needs and/or plant material.
- 3. All repairs will be carried out as necessary and billed at \$50.00 per man hour plus parts.
- 4. All repairs necessitated by contractor's personnel will be repaired by the contractor at no expense to the HOA.
